Salu Street: Recently it was brought to our attention that the city had started laying asphalt on Salu Street between Humbert and Elizabeth Streets. That section of Salu Street is protected by Alton's Brick Street Preservation Ordinance. A call to the mayor's office stopped all action on Salu Street. The mayor called President of AALA, Terry Sharp and said it was a mistake and the asphalt would be removed from the street. However, at the next city council meeting, the council changed the law, in one session, and removed that section of Salu Street from the ordinance. This action from the council is disappointing and distasteful. The AALA will continue to speak up to protect the historic elements of Alton we all know and love.
